RE: Convention Voting Rights

The Constitution of Delta Sigma Phi is very specific on who may vote at the Convention and how those voting rights must be certified. *Please read this memo very carefully and be sure to respond accordingly.*

ALUMNI ASSOCIATIONS AND ALUMNI CHAPTERS

- Alumni Associations and Alumni Chapters in good standing with 50 or fewer members are eligible for one vote. Alumni Associations and Alumni Chapters in good standing with more than 50 members are eligible for 2 votes.
- Delegates **MUST** complete and submit the appropriate attached certification form by June 20, 2007.

CHAPTER ADVISORS

- Chapter Advisors are eligible for one vote.
- If the Chapter Advisor is the voting delegate, no certification is necessary.
- The Chapter Advisor may assign his vote to the ACB President (and only the ACB President). In this case, the Chapter Advisor **MUST** complete and submit the appropriate attached certification form by June 20, 2007.

GRAND COUNCIL MEMBERS

- Members of the Grand Council are eligible for one vote.
- No certification is required.

REGIONAL AND DEPUTY REGIONAL COMMISSIONERS

- Regional and Deputy Regional Commissioners are eligible for one vote.
- No certification is required.
